



Membership Rule issued by the AHANA Board under Clause 3 of By-law No. 2022 – 01 ‘Membership classes, membership application procedures and recognition of non-member credentials’ (known as 2023/24 Fee Schedule, Rule 2.0)

For the purpose of this Rule:

- a) **AHA** means Allied Health Assistant, as defined in By-law 2022-01.
- b) **Register** means the Register of Allied Health Assistants, as defined in By-law 2022-01.

* If a member currently holding a Student, Associate or Non-Practising Member class is required to apply for a Practising Membership within a membership period, they will receive a discount on their new membership fee which equates to the amount of their initial membership and application fee

* If a current Student Member is required to apply for an Associate Membership within a membership period, they will receive a discount on their Associate Membership fee equating to the amount paid for their initial membership and application fee.

^ Prior to 15 May 2024, AHANA offered a fixed membership period from 1 July to 30 June each year. Members who joined after July each year were appointed on a pro-rata basis. From 15 May 2024, AHANA membership is for a 12-month period from the date of joining.
